## CHIP IN FOR CHARITY REGISTRATION

### How does Chip In for Charity Work?

In Chip In for Charity, charities and other community organizations can sell tickets to the Travelers Championship for the discounted price of \$20, and 50% of the profits will be donated back to the group. Ticket buyers obtain a discounted ticket, and the organization raises \$10 per ticket sold- it's a win-win for everyone!

### Participating is easy!

1. Who's eligible? All nonprofits, community groups, scout troops, teams, etc. Organizations subject to approval by the Travelers Championship.
2. Register with the Travelers Championship and we'll provide tickets and the materials you'll need to get started.
3. Sell tickets! Tickets are valid for General Admission, Any One Day, Monday, June 16 - Sunday, June 22.
4. Submit unsold tickets and 100% of funds received to the Travelers Championship. There is no penalty for unsold tickets. *(Please note, tickets are numbered and tracked- unsold tickets that are attempted to be redeemed, will not be honored at the gate.)*
5. The Travelers Championship will send you a check for 50% of the sales.

### How much money can my charity raise?

Fundraising potential is limitless!  
Sell 50 tickets, Raise \$500!  
Sell 100 tickets, Raise \$1,000!

### How many tickets does my Charity need?

- Simply, it's based on how much you want to raise for your group. Divide your goal by the profit you'll receive per ticket- \$10.

### Important Dates

February - June 2008: Ticket sales  
June 4, 2008: 100% of funds collected and unsold tickets must be returned to Travelers Championship  
Fall 2008: Funds raised will be distributed
