Information travelerschampionship.com gathers and tracks:

Registration

Anyone who registers for the Travelers Championship Fan Zone or purchases tickets or merchandise on the Website will be asked to supply some information. We use customer contact information from this registration form to send the use information about our tournament, charities and sponsors. Financial information that is collected is used to bill the user for purchases. The customer's contact information may also used to contact the visitor when necessary for customer service reasons. Users may opt-out of receiving future mailings; see the choice/opt-out section below. No information collected on the Website will be made available to any third party for any other purposes.

CHILDREN UNDER THE AGE OF 13

We do not currently collect any personally identifiable information from children under the age of thirteen. Children of any age should always ask a parent for permission before sending personal information to anyone online. If, in the future, Travelerschampionship.com collects personally identifiable information from children under the age of thirteen, it will do so in compliance with the Children's Online Privacy Protection Act of 1998 (15 U.S.C. § 6501 et seq.)

IP Address

We may use your IP address to help diagnose problems with our server, and to administer our Web site. Your IP address is used to help identify you and your shopping cart.

Cookies

A cookie is a small data file that certain Web sites write to your hard drive when you visit them. A cookie file can contain information such as a user ID that the site uses to track the pages you've visited. However, the only personal information a cookie can contain is information you supply yourself. Generally, cookies work by assigning a unique number to the user that has no meaning outside the assigning site. A cookie can't read data off your hard disk or read cookie files created by other sites. This random number lets us keep track of "how many" times customers are doing specific things -like visiting our site each month - without really knowing who those customers are. We also use cookies to keep track of your shopping cart.

If a user does not want information collected through the use of cookies, there is a simple procedure in most browsers that allows the user to deny or accept the cookie feature; however, users should note that cookies may be necessary to provide the user with certain features (e.g., purchase order tracking).

Order Forms, Volunteer Applications and Sponsorship Information Forms

Travelerschampionship.com's site uses an order form for customers to purchase tickets and merchandise. The Website also has forms for volunteer applications and requests for sponsorship information. If you place an order at Website, we will collect information from you, including your credit card and contact information. This information will be used by the merchant to bill the user for products. Contact information from the order form will also be used to ship orders, to contact a user for customer service related issues, and to send the user information about the Tournament. Information on the Volunteer Application and Sponsorship Information Request forms is used solely for the purposes of the relationship between the Tournament and the individual(s) completing the forms. No other use of that information will be made and the information will not be provided to any third party.

Fan Zone

We offer a free Fan Zone to share content information about our site and tournament with interested users. Users may cancel their free membership or unsubscribe to any email newsletters by following the simple instructions at the bottom of each newsletter or e-mail.

Use of Information

All of the information Travelerschampionship.com collects, both what you tell us and what we collect through the use of cookies, is "aggregated" -- meaning that the information from many users is grouped together in a way that does not disclose the personal information of any particular user. We may use this aggregated information to evaluate which products are successful and which ones are not, and in order to
